AAG is a not-for-profit membership-led organisation, structured as a company limited by guarantee. It is Trustee for the Australian Association of Gerontology Research Trust, as well as being the executive office for the International Association of Gerontology and Geriatrics - Asia Oceania Region and the International Longevity Centre – Australia. AAG's flagship publication, of which it is part owner, is the Australasian Journal on Ageing.

- ▶ **Collaborative** - AAG brings together its members and key stakeholders to progress improvements in the experience of ageing
- ▶ **Fair** - AAG is committed to promoting equity of access and outcomes for all older people in Australia and internationally

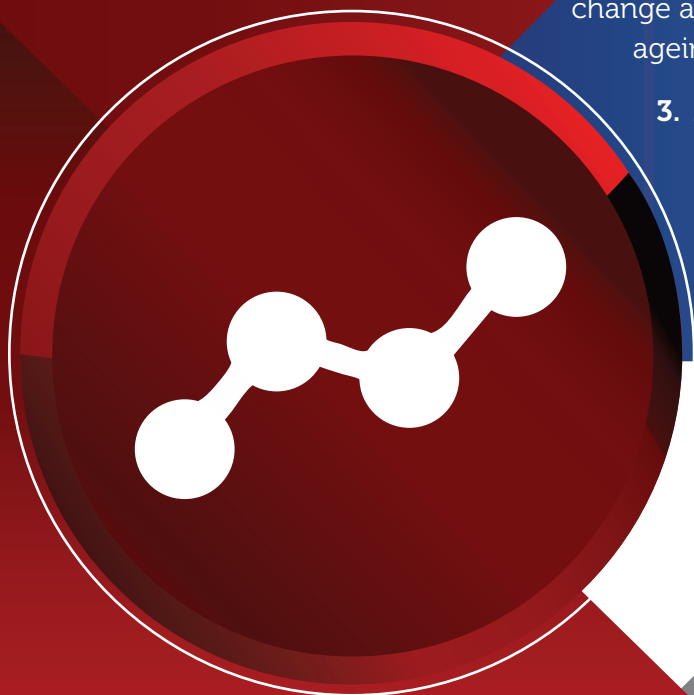
GOALS

AAG's Strategic Priorities 2020-2023 include four goals, each framing broad actions required to achieve them.

GOAL 1

DEMONSTRATE **LEADERSHIP** THROUGH **SETTING THE** **AGEING AGENDA**

- 1. Advocate for and promote evidence informed, holistic thinking** and action as the gold standard
- 2. Lead and participate in forums, activities and advocacy** that set the agenda for change and innovation in ageing and gerontology
- 3. Maintain global connectivity** through ageing-focused international bodies



GOAL 2

STRENGTHEN INNOVATION AND COLLABORATION TO INCREASE IMPACT AND REACH

- 1. Develop creative and productive partnerships** across all ageing related sectors and disciplines, including with politicians and all levels of governments
- 2. Amplify the voice of members** including through AAG's state/territory divisions and special interest groups
- 3. Improve outcomes for Australia's First Nations older people and their communities**, with direction by the Aboriginal and Torres Strait Islander Ageing Advisory Group (ATSIAAG)

ENSURE EVIDENCE FROM **MULTIPLE PERSPECTIVES** IS AT THE CENTRE OF **POLICY AND PRACTICE**

1. Influence development, implementation and evaluation of policy on all aspects of ageing on which AAG members have expertise to contribute

2. Facilitate events that enhance and support impact on research, education, policy and practice

3. Target program and practice improvement across sectors that engage older people
